SEX OFFENDER SUPERVISION

(WQOW) - Prison time was ordered Tuesday for a Wisconsin man accused of sexual assault.

Brian Anglin, from River Falls, was charged in 2015 with repeatedly sexually assaulting a six-year-old girl. She said he also threatened to burn her with a lighter if she told anyone.

As part of a plea bargain, the sexual assault charge was dismissed, but considered at sentencing, along with two convictions for bail jumping.

Anglin will spend six years behind bars.

MADISON (WKOW) - Family members of an arrested, Madison grade school teacher believe in his innocence, and await more details of the allegations against him.

Madison Police officials say 50-year-old Leopold Elementary School teacher Terry Fay surrendered to authorities Friday. Officials say Fay sexually assaulted a student five years ago, beginning when the child was ten years old. Authorities say the victim is now a teenager living out of state, and recently reported what happened.

Fay's brother, Dan Fay tells 27 News Terry Fay has been a champion of children. "Excellent (with children), and that's why people request him for a teacher." Dan Fay says. "He's an excellent teacher. His children are excellent teacher as well."

Fay's attorney, Jordan Loeb tells 27 News Terry Fay's home was searched by Madison Police officers Sept. 29, with electronics, and possibly other

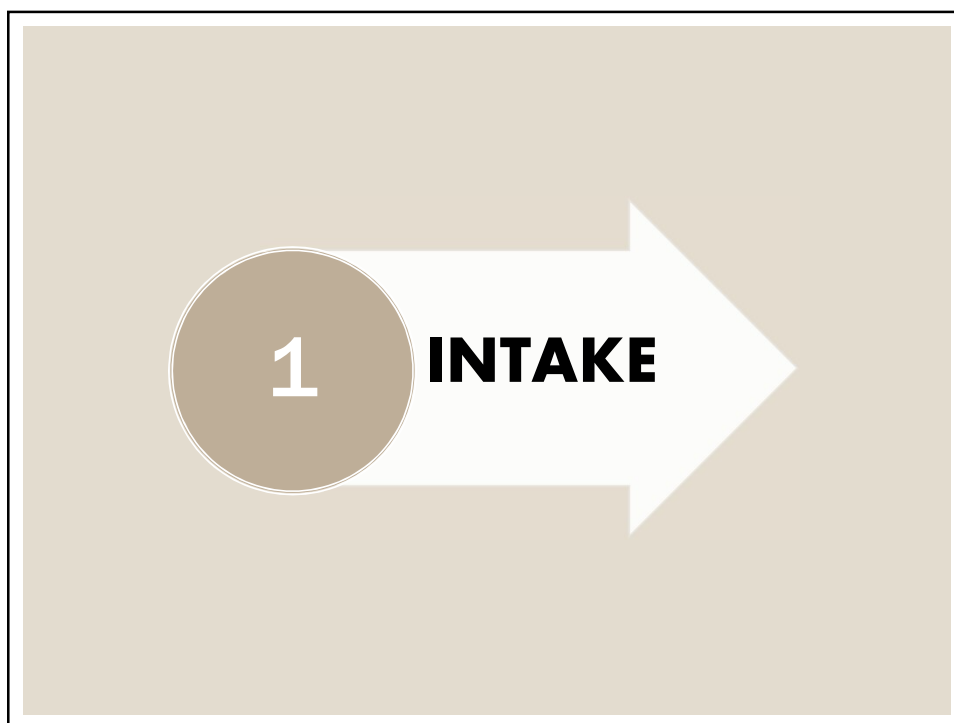
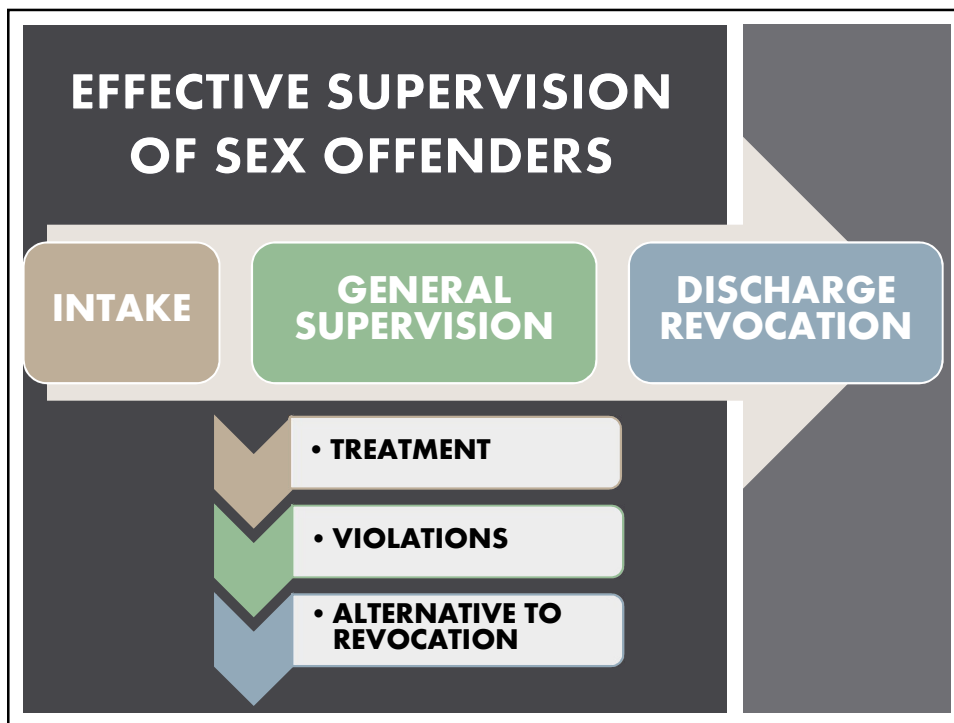

WHO GETS SUPERVISED AS A SEX OFFENDER?

Sex Offender Definition: AD 15-16

A sex offender is defined as “a person whose criminal history includes a conviction, adjudication, or read-in for sexually assaultive or sexually motivated behavior; or a person who has a substantiated allegation (through PREA, investigation, revocation, or other means) of sexually assaultive or sexually motivated behavior whether or not it has been criminally charged; or a person who is required to register as a sex offender per WI State Statute 301.45.” “Sexually motivated” means that one of the purposes for an act is for the actor’s sexual arousal or gratification or for the sexual humiliation or degradation of the victim



SEX OFFENDER INTAKE PROCESS

- Sex Offender Assessment
- Sex Offender Registry
- Sex Offender Rules
- Residence Assessment / Residency Restrictions
- Face to Face contact with local Law Enforcement
- Treatment Referrals

ASSESSMENT PROCESS

- **COMPAS Core Assessment**
 - All Offenders on active supervision have this completed.
- Agents have the option to utilize approved trailer tools.
- Most commonly used is the STATIC-99R

SEX OFFENDER RULES

6 STANDARD RULES – AVAILABLE IN COMPAS

- 1 • Not have contact or attempt contact with victim nor any prior victims of your offenses nor their family members without prior agent approval. Contact includes face-to-face contact, contacts facilitated by third parties and any other forms of communication including but not limited to telephone, computer, mail or any other electronic or scientific means.
- 2 • Fully cooperate with, participate in, and successfully complete all sex offender evaluations related to risk and treatment.
- 3 • Fully cooperate with, participate in, and successfully complete all sex offender services deemed appropriate through the sex offender evaluation process. Successful completion shall be identified through completion criteria determined through the sex offender standards.

SEX OFFENDER RULES CONT.

6 STANDARD RULES – AVAILABLE IN COMPAS

- 4 • Not reside nor “stay” overnight in any place other than a pre-approved residence without prior agent approval. “Overnight” is defined as the daily period of time between the hours of ____ and ____ unless redefined by your agent in advance.
- 5 • Permit no person to reside nor stay in your residence between the hours of ____ and ____ without prior agent approval.
- 6 • Comply with any additional sex offender rules that may be established by your agent. The rules may be modified at any time as appropriate.

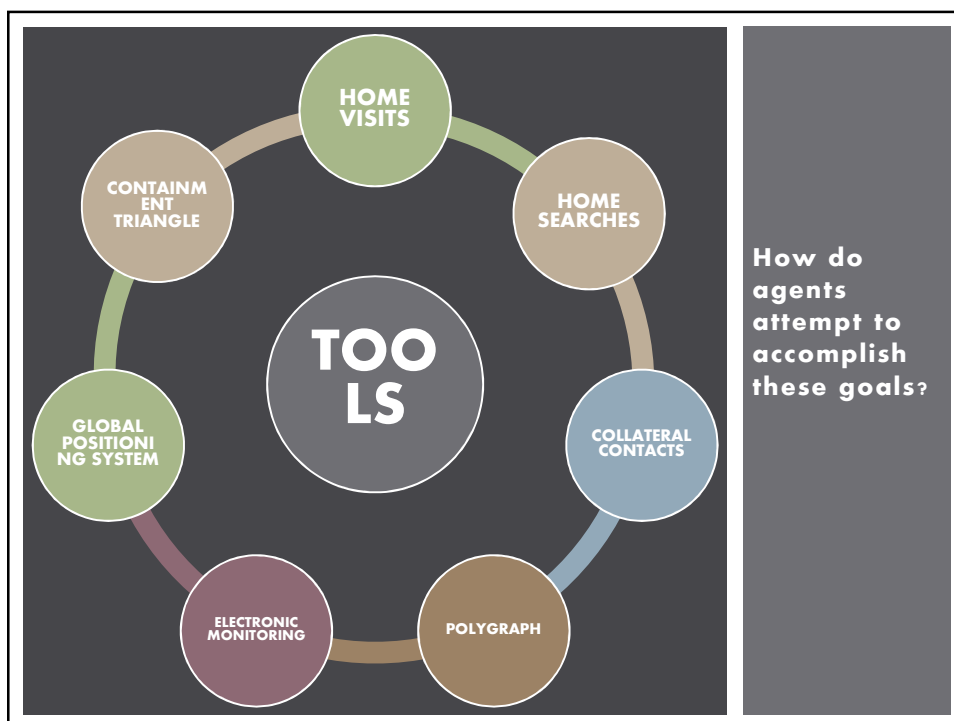
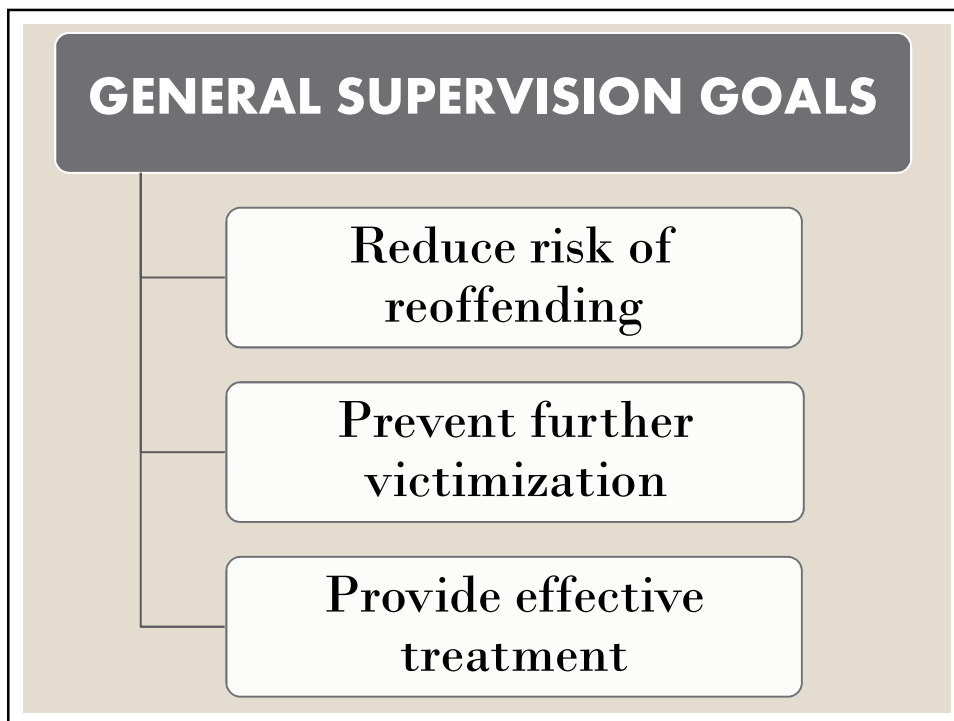

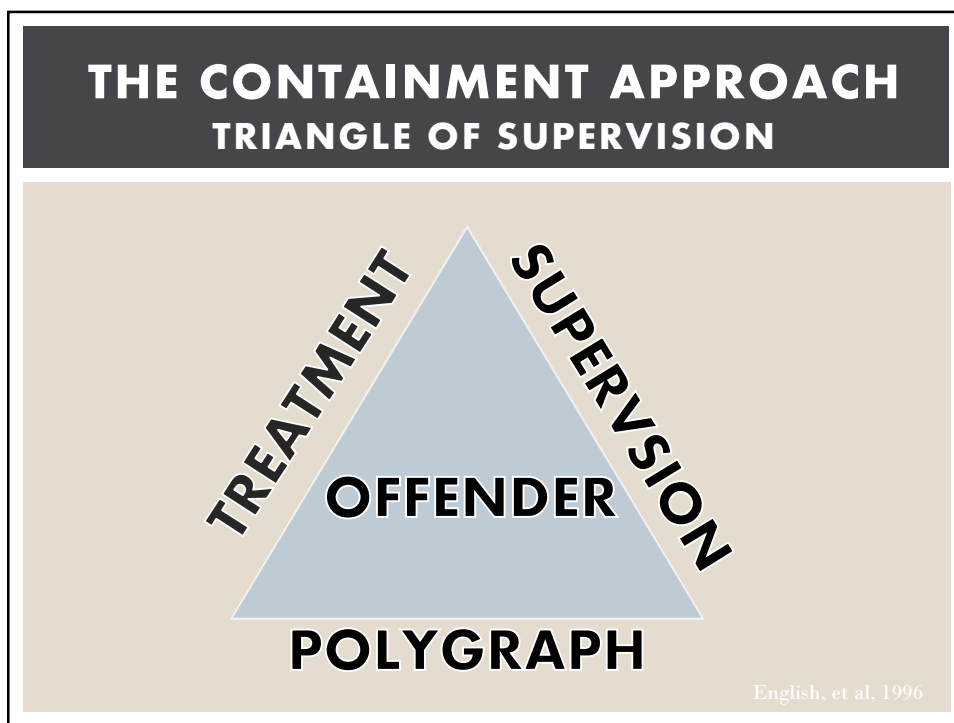
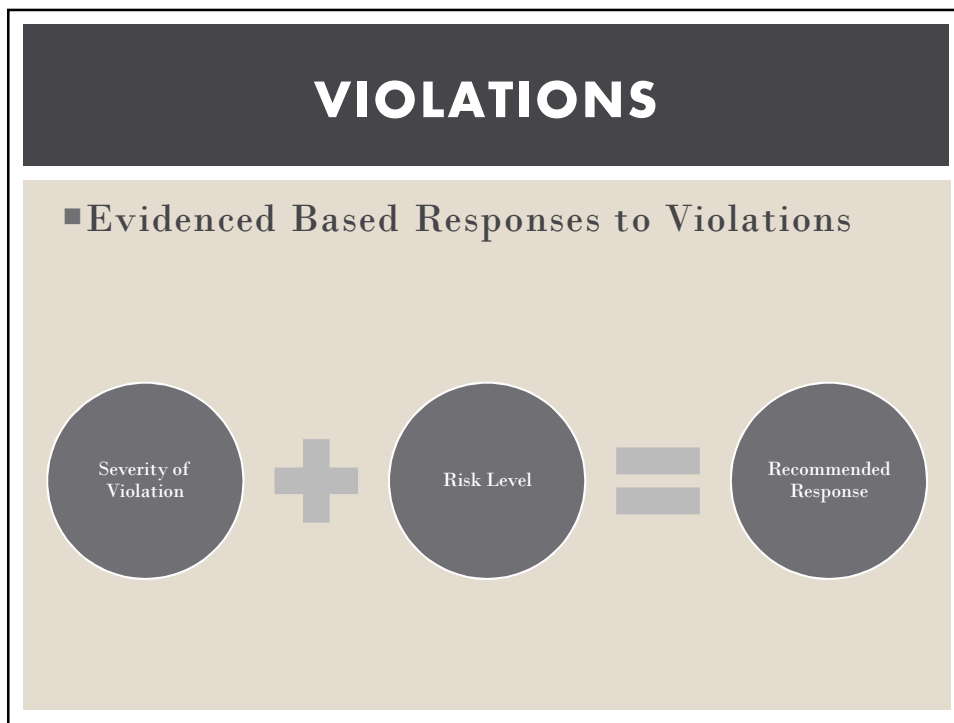
UP TO 9 SPECIAL RULES CAN BE ADDED BASED ON CRIMINOGENIC
NEED & NEXUS TO CRIME


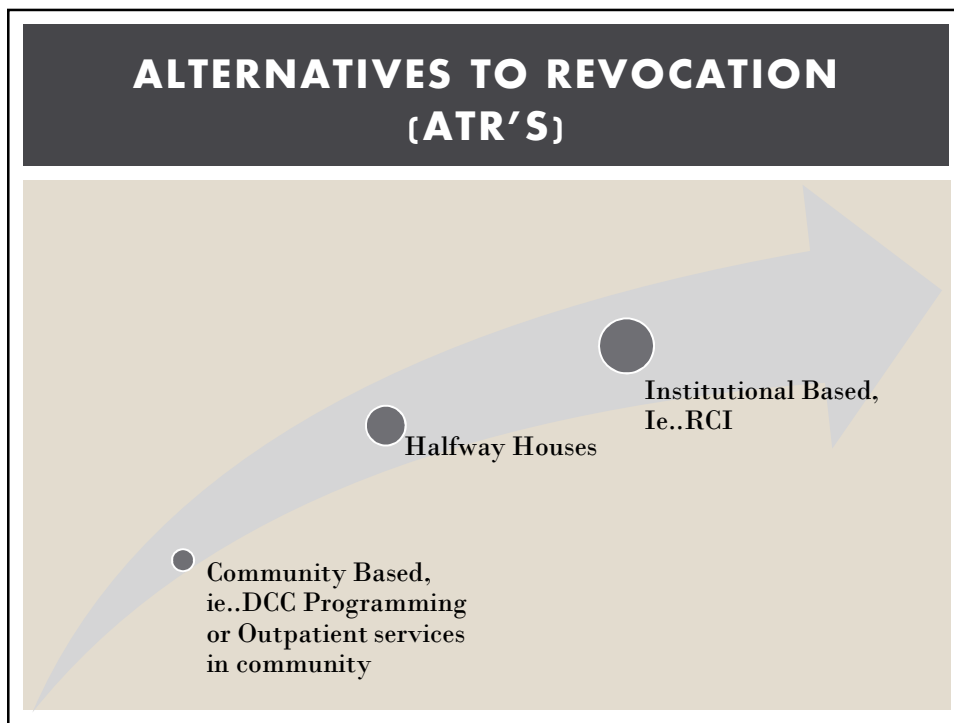
1. You shall not have contact or attempt contact with anyone under the age of 18 without prior agent approval and unless accompanied by an adult sober chaperone approved by your agent. Contact includes face-to-face contact, contacts facilitated by third parties and any other forms of communication including but not limited to telephone, computer, mail or any other electronic or scientific means.
2. You shall not be present in a location that is frequented by minor children without prior agent approval and unless accompanied by an adult sober chaperone approved by your agent.
3. You shall not gain nor attempt to gain access to the internet without prior agent approval.
4. You shall not possess nor view any material that depicts any intimate parts of an adult. [“Intimate parts” means the breast, buttock, anus, groin, scrotum, penis, vagina or pubic mound of a human being as defined in Wisconsin s. 939.22(19).]
5. You shall not possess nor view any material that depicts any intimate parts of a child or adolescent. [“Intimate parts” means the breast, buttock, anus, groin, scrotum, penis, vagina or pubic mound of a human being as defined in Wisconsin s. 939.22(19).]
6. You shall not possess material marketed to children including but not limited to clothing, written material, toys and games.
7. You shall not establish, pursue, nor maintain any dating, romantic, or sexual relationship without prior agent approval.
8. You shall fully comply with all sex offender registry requirements as applicable and directed by your agent and/or required by statute. You shall immediately respond to all correspondence from the Sex Offender Registry Program.
9. You shall submit to the polygraph (lie detector) examination process as directed by your agent in accordance with Wisconsin Administrative Code 332.15. You shall pay fees for the polygraph (lie detector) examination process as directed by your agent in accordance with Wisconsin Administrative Code 332.17(5) and 332.18 and shall comply with any required Wisconsin Department of Corrections procedures regarding payment of fees.

- Polygraph Prep

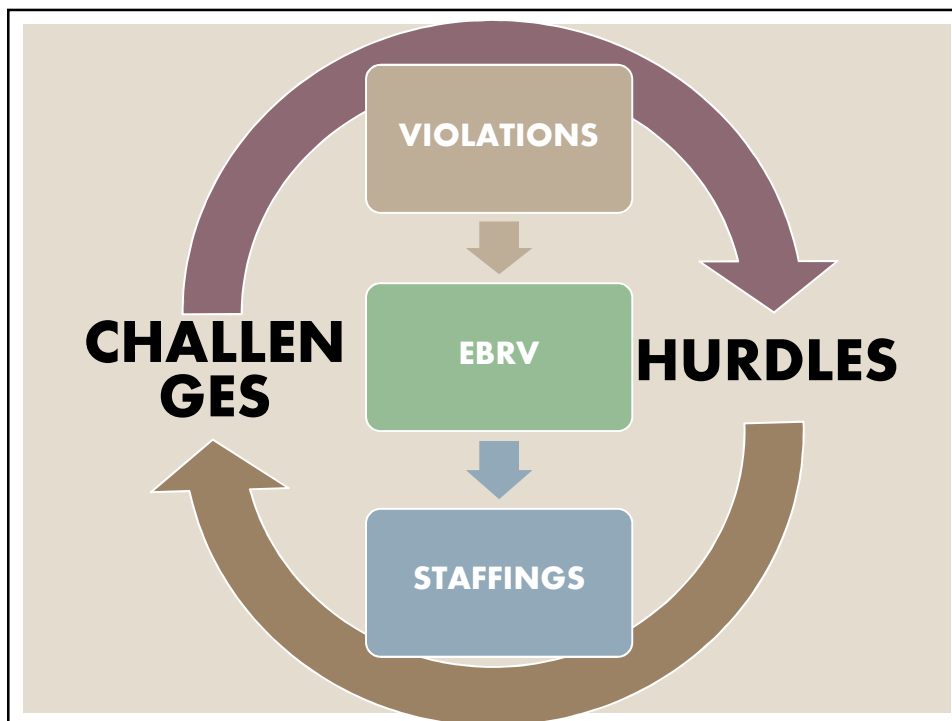
DIFFERENCES IN TREATMENT STAFFINGS?

Region 3

- Do have Sex Offender specific Units (5 units in total)
- Each sex offender unit meets weekly to staff cases
 - Once per month a representative from the treatment provider attends staffings

Region 8

- Do Not have specific Sex Offender Units
- Weekly meetings with SOT Treatment Provider/Facilitator
- Northern Region 8 Sex Offender Staffings held about once every two months
- Region 8 Sex Offender - Specialized Supervision Program held once every six months



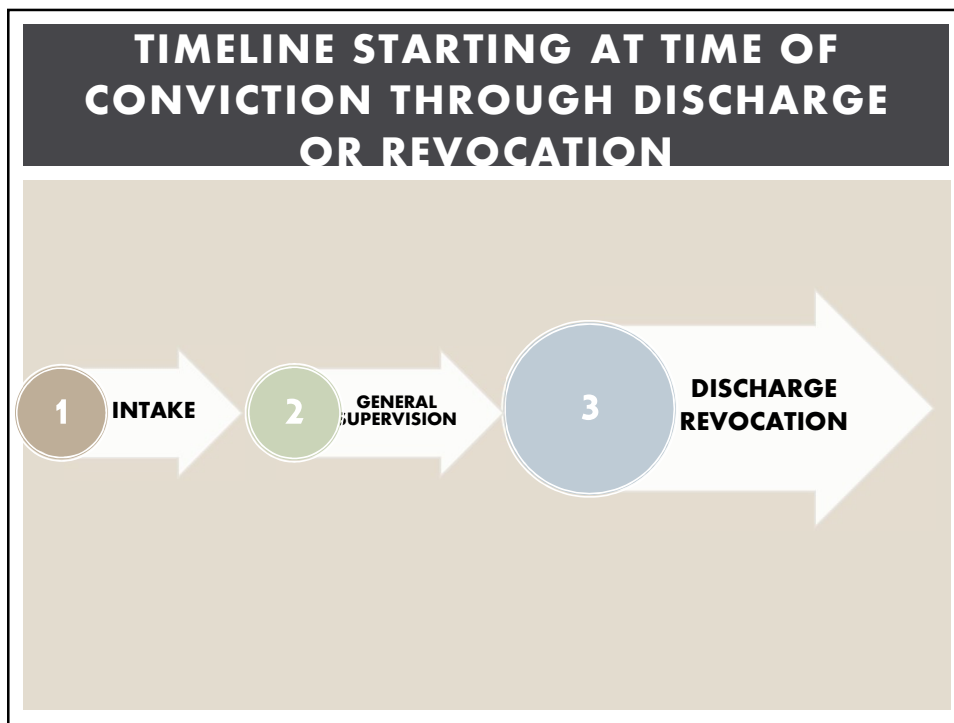
SEX OFFENDER RESIDENCY RESTRICTIONS

■ Key Points:

- Wisconsin does not have a comprehensive statewide law regarding where sex offenders can and cannot live
- Every municipality may have their own restrictions which differ from neighboring communities
- Most (if not all) residency restrictions only apply to offenders whose victims were children

■ Challenges:

- Residential instability including possible homelessness
- Lack of residential stability undermines the purpose of the Sex Offender Registry
- Varying laws can lead to uncertainty about the legality of residences
